

"AN ORDINANCE AUTHORIZING THE ISSUANCE
OF PROVISIONAL OPERATORS' LICENSES"

ORDINANCE NO. 24

The Town Board of the Town of Oakland, Wisconsin, DO
ORDAIN as follows:

Sec. 1 of the Oakland Municipal Code shall be
created to read as follows:

1. Pursuant to the authorization granted to municipal-
ities by sec. 125.17(5), Wis. Stats., the Town Clerk of the Town
of Oakland shall hereafter be authorized to issue provisional
operators' licenses without prior approval of the Town Board of
the Town of Oakland.

2. Such licenses shall be issued only by the Town
Clerk and only to a person who has applied for an operator's
license pursuant to the procedure authorized under sec.
125.17(1), Wis Stats.

3. Such licenses shall not be issued to anyone who has
previously been denied an operator's license under sec.
125.17(1), Wis. Stats., by the Town of Oakland Board.

4. The Town Clerk for the Town of Oakland may revoke
any provisional operator's license if he or she discovers that
the holder of such license made a false statement on the applica-
tion therefor.

5. A provisional operator's license shall expire sixty
(60) days after issuance or when a license under sec. 125.17(1),
Wis. Stats., is issued or denied to the holder by the Town Board,
whichever is sooner.

~~6. Any applicant for a provisional operator's license
shall pay a fee of \$2. Such fee shall be for the sole purpose of
applying for the provisional operator's license and no amount
shall be applied to the separate fee for applying for an oper-
ator's license under sec. 125.17(1), Wis. Stats.~~

**AN ORDINANCE TO AMEND ORDINANCE #24 AUTHORIZING
THE ISSUANCE OF PROVISIONAL OPERATOR'S LICENSES**

ORDAIN as follows:

Paragraph Number 6. of Ordinance No. 24 of the Town of Oakland shall be
amended to read as follows:

6. Any applicant for a provisional operator's license shall pay a fee as
established in Ordinance No. 53. Such fee shall be for the sole purpose of
applying for the provisional operator's license and no amount shall be applied
to the separate fee for applying for an operator's license.

The Town Board DO FURTHER ORDAIN that this Ordinance shall become
effective upon adoption, posting and/or publication.

This ordinance shall take effect from and after its passage and publication or
posting as provided by law.
