

ORDINANCE NO. 53

AN ORDINANCE TO ESTABLISH LICENSE FEES FOR  
THE TOWN OF OAKLAND

The Town Board of the Town of Oakland, Jefferson County, Wisconsin, DO  
ORDAIN as follows:

Ordinance No. 53 shall be created to read as follows:

1. The Town of Oakland sets the following fees for the issuance of licenses for the sale of fermented malt beverages and intoxicating liquors pursuant to the authority granted in ch. 125, Wis. Stats.:
  - A. **Class "A" Fermented Malt Beverages Retailer's License.** The annual fee for this license shall be one hundred dollars (\$100.00). The fee for a license for less than twelve (12) months shall be prorated according to the number of months or fraction thereof for which the license is issued.
  - B. **Class "B" Fermented Malt Beverages Retailer's License.** The annual fee for this license shall be one hundred dollars (\$100.00). The fee for a license for less than twelve (12) months shall be prorated according to the number of months or fraction thereof for which the license is issued.
  - C. **Temporary Class "B" Fermented Malt Beverage Retailer's License.** The fee for this license shall be ten dollars (\$10.00) per event, except that if a Temporary "Class B" Wine License is obtained along with this license, the fee for each license shall be five dollars (\$5.00) per event.
  - D. **Temporary "Class B" Wine License.** The fee for this license shall be ten dollars (\$10.00) per event, except that if a Temporary Class "B" Fermented Malt Beverage Retailer's License is obtained along with this license, the fee for each license shall be five dollars (\$5.00) per event.
  - E. **Fermented Malt Beverage Wholesaler's License.** The fee for this license shall be twenty-five dollars (\$25.00) per year or fractional part thereof.

- F. **“Class A” Intoxicating Liquor Retailer’s License.** The annual fee for this license shall be three hundred fifty dollars (\$350.00).
  - G. **“Class B” Intoxicating Liquor Retailer’s License.** The annual fee for this license shall be three hundred fifty dollars (\$350).
  - H. **Reserve “Class B” Intoxicating Liquor Retailer’s License.** In the event that one is available, the fee for the initial issuance of a reserve “Class B” license, as defined in sec. 125.51(4)(a) 4., Wis. Stats, and as hereafter amended, shall be ten thousand dollars (\$10,000), plus the fee for a regular “Class B” license established in subsec. G, above. The annual fee for the renewal of a reserve “Class B” license, if one is available, is the fee established in subsec. G, above.
  - I. **“Class C” Wine License.** The annual fee for this license shall be one hundred dollars (\$100.00). The initial fee for less than twelve (12) months shall be prorated.
2. The Town of Oakland sets the following fees for the issuance of operators’ licenses pursuant to the authority granted in ch. 125, Wis. Stats.:
- A. **Operator’s License.** The annual fee for an original operator’s license, as well as for any renewals thereof, shall be twenty-five dollars (\$25.00).
  - B. **Provisional Operator’s License.** The fee for a provisional operator’s license shall be fifteen dollars (\$15.00).
  - C. **Temporary Operator’s License.** The fee for a temporary operator’s license shall be five dollars (\$5.00).
  - D. **Agent Change.** A corporation or a limited liability company shall, following the approval of a successor agent or other qualified agent by the Town of Oakland, pay a fee of ten dollars (\$10.00).
3. The Town of Oakland sets the following fee for the issuance of a cigarette license pursuant to the authority granted in sec. 134.65, Wis. Stat.:
- Cigarette License Fee.** The annual fee for a cigarette license shall be twenty-five dollars (\$25.00).

4. In the event that any of the above licenses are revoked or surrendered for any reason during their term, there shall be no refund issued for the remaining term or fraction thereof.

This ordinance shall take effect from and after its passage and publication or posting as provided by law.
